Political risk and human rights impact assessments are indispensable to business. Uncertainty surrounding government regulation, fiscal stability, corruption, the rule of law, currency inconvertibility, and unexpected imposition of economic sanctions or export/import license requirements have been longstanding factors contributing to complex and volatile economic markets, particularly in emerging markets or conflict zones. The lack of government capacity or willingness to regulate and enforce human rights in countries where income inequality and socioeconomic unrest are present have also heightened the corporate responsibility to assess and manage human rights issues and the potential of sanctions imposed to counteract human rights abuses.
