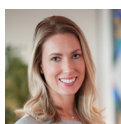


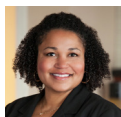
GLOBAL PUBLIC COMPANY ACADEMY

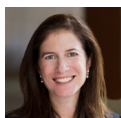
