Morgan Lewis Nabs Ex-Credit Suisse Director For Tax Practice

Bart Bassett, the head of Morgan Lewis' tax practice, said he believed Nelson's experience would be an asset to the firm and its clients.

"Sarah has a deep understanding of the key business drivers of the tax aspects of a wide variety of transactions," Bassett said. "Her work on various asset classes, both in the law firm and global financial institution environments, fully equips her to take on the complex tax review and analysis most transactions require."

Nelson received her undergraduate degree from Stanford University and her law degree and master of laws in taxation from New York University. She is a member of the Structured Finance Industry Group and Commercial Real Estate Finance Council.
