## Morgan Lewis Nabs 2 Bracewell Partners For Dallas Office

Law360 (May 15, 2019, 8:14 PM EDT) -- Morgan Lewis & Bockius LLP has beefed up its Dallas presence by adding a seasoned labor and employment litigator and an experienced mergers and acquisitions attorney as partners from Bracewell LLP.

Robert Sheeder, who was the head of Bracewell's labor and employment practice group, and Janice Davis, who was the co-chair of Bracewell's technology transaction group, have jumped ship to Morgan Lewis with two other attorneys, according to an announcement last week. The partners joined the firm with Lauren West, who serves as of counsel, and Clayton Davis, an associate.

Sheeder told Law360 that part of what piqued his interest about Morgan Lewis was when Philip Miscimarra — whom he worked with at what is now Reed Smith LLP — decided to rejoin the firm after leaving his position as chairman of the National Labor Relations Board. Sheeder also commended the firm on its labor and employment practice.

"In my own case, I do labor and employment, and Morgan Lewis has the finest labor and employment group and practice in the nation. And I've always been impressed by them, and they set the standard," Sheeder said.

Sheeder said he works on a lot of litigation, including trials, defending against class and collective actions and claims including discrimination, harassment and wrongful discharge. He also does a lot of traditional labor work, like collective bargaining, arbitrations and NLRB-related work, he said.

He was at Bracewell for about 13 years, he said, and before that he spent 15 years at Jenkens & Gilchrist PC. Before that, he spent about six years at Winstead PC, where he started the firm's labor section, he said, and he also worked at Reed Smith.

He represents clients in various industries, including oil refineries, news publications and accounting firms, he said.

Janice Davis, who focuses on representing clients in the health care and technology spaces, said she was presented with an excellent chance to join a firm with a great reputation for its mergers and acquisitions practice and for client service.

"I'm a corporate attorney and I focus on mergers and acquisitions, and obviously, Morgan Lewis has a great mergers and acquisitions team," she said. "It advises clients on a range of global mergers and acquisitions and has approximately 70 attorneys on the mergers and acquisitions team. I thought it was a great opportunity to join a deep and diverse team that is particularly strong in the mergers and acquisitions and private equity space."
