## Morgan Lewis Adds Immigration Attys From Baker McKenzie



Law360 (January 7, 2019, 7:11 PM EST) -- Morgan Lewis & Bockius LLP said Monday that it has added two labor and immigration attorneys previously with Baker McKenzie, one as a partner in Washington, D.C., and one as of counsel in Miami.
