Morgan Lewis Adds Ex-Schnader Harrison Atty In Pittsburgh

John Gisleson, who has more than two decades of experience in litigation and has brought more than 15 cases to verdict in multiple jurisdictions, has joined the firm as a partner on Feb. 20. Gisleson was previously a partner in Schnader Harrison Segal & Lewis' litigation practice, where he formerly served as co-chair.
