



Environmental Justice

- Initial focus on the "fair" distribution of environmental benefits and burdens
- Defined by the EPA as "the fair treatment and meaningful involvement of all people regardless of race, color, national origin, or income, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies"



Biden Campaign Promises Related to Environmental Justice

- "All of Government" approach to address environmental justice
- Make decisions that are driven by data and science
- Target resources in a way that is consistent with prioritization of environmental and climate justice
- Assess and address risks to communities from the next public health emergency

Initial Directives from Biden Administration

- April 7, 2021 memo directing EPA staff to "infuse equity and environmental justice principles and priorities into all EPA practices, policies, and programs"
 - Administrator Regan: "integrating environmental justice and equity into the very DNA of EPA"
- Specifically:
 - Strengthen enforcement of violations in areas that have been encumbered by pollution
 - More frequent underserved community engagement in rulemaking
 - Prioritize environmental justice in the grants process
 - Have regular and meaningful conversations with Tribal officials





NEPA

- Executive Order on first day directing CEQ review of Trump's changes to NEPA
- Undoing Trump ERA changes cumulative impacts and environmental justice
- Considering new approaches
 - Detailed mapping of environmental justice areas and overburdened communities
 - Evaluation of climate change impacts on environmental justice communities
 - Identifying appropriate mitigation



Looking Forward

- Changes in NEPA could result in federal dollars being spent on clean energy projects as opposed to traditional energy projects
- Pressure on the Biden administration to consider changes to NEPA:
 - Pressure from the left to strengthen NEPA
 - Pressure from clean energy businesses to make exceptions for their projects
 - Bills circulating in Congress regarding integrating Title VI of the Civil Rights Act within NEPA
 - And bills purporting to strengthen NEPA



Impact on Current NPL Sites and on the NPL Selection Process

- Current Superfund sites located near underserved communities
 - Some estimate as high as 70% are within a mile of public housing
 - Pressure from the Biden EPA to address those sites?
- Environmental justice a factor in selecting NPL sites?
- Intersection of climate change and Superfund sites
 - Reports show that many sites are threatened by natural disasters, including those near underserved communities
- Removal of sites from the NPL
 - Claims that prior administration's removal of sites have neglected communities of color
 - Environmental justice a factor in future removal from NPL?



Change in DOJ Policy

- Supplemental Environmental Projects (SEPs) were frequently used by the Obama DOJ
 - Phased out by the Trump administration, but still frequently used by states
- In early April, the DOJ's Environment and Natural Resources Division withdrew several policy documents which disallowed SEPs in settling environmental liability
- Looking forward, SEPs with an environmental justice focus could become important negotiating tools
 - Still early to see what these types of SEPs will look like at the federal level, but states like California could provide clues





Proposed Infrastructure Bill

- Part of Biden's plan to tie together climate change and environmental justice
- Biden's plan aims to assist communities of color and underserved communities by securing infrastructure improvements
 - And to ensure that communities are environmentally safe
- Notably, the bill provides billions of dollars to replace lead water pipes



Bill as a Harbinger

- Environmental justice initiatives to receive more resources and attention
- Campaign promises → tangible policy proposals
