

# Regional outlook

## The Gulf Cooperation Council

#### Kuwait


- Population of 4.5 million, including expats
- Silk City megaproject
- Vision 2035 "New Kuwait"

#### Saudi Arabia

- Population of 35 million, 1/3 expats
- Largest economy in MENA
- ICT market estimated at \$40bn and growing
- "Vision 2030"

#### Oman

- Population of 5 million, 89% below 50
- Lowest unemployment rate
- Digital transformation program 2021-2025
- "Vision 2040"



#### **Bahrain**

- Population of 1.5 million
- 2<sup>nd</sup> top diversified economy in MENA
- Cloud-first, "Data Embassy" regime for US cloud providers

#### Qatar

- Small (3 million) but cash rich population
- FIFA World Cup 2022
- Almost 100% urbanized
- GCC / Qatar embargo lifted in January 2021

#### UAE

- Population of 10 million
- +/- 1 million UAE Citizens
- 4.2% GDP growth in 2023
- "Vision 2021" and "We the UAE 2031"

- Members of WTO and TRIPS

# **Regional specifics**

- ✓ IP legislation is new
- ✓ The GCC countries are signatory to several (but not all!) major international conventions and treaties
- ✓ Scrutiny on potential violation of public order or morals
- ✓ Severe penalties for IP rights' violation
- ✓ Enforcement practice is uneven
- ✓ Close work with the authorities is necessary for successful enforcement

- ✓ Federal level legislation vs legislation in free zones
- ✓ Regulatory requirements to trade activity
- ✓ National security and defense considerations (including data collection and sharing issues)



Complex assessment on scope of registration and future use of IP is necessary

- Berne Convention automatic protection of copyright
- National legislation

- Software protected by copyright in all GCC countries
- "Work for hire" concept

#### **Enforcement**

- Registration / depositing
  - voluntary, but recommended to create presumption of ownership
- Administrative proceedings
  - designated bodies
  - border control
  - competition authorities
- Civil proceedings
- Criminal liability



# **Patents**

stopped accepting new patent applications

## **Legal framework**

- Patent Cooperation Treaty
- The Gulf Cooperation Council (GCC) Patent Office: in January 2021 stopped accepting new GCC patent applications and resumed work in January 2023

# What you need to know

- Scrutiny to ensure no conflict with the general order or the rules of Islamic Sharia or adversely affect to national security or public morals
- Export control type regulations for patent applications
- Arabic translations of applications
- Time consuming registration procedure
- Trend to move from an absolute novelty concept to a novelty grace period concept
- Post-grant oppositions
- Protection of designs and utility models

# **Enforcement of patents in the UAE**

- No specialized IP courts; proceedings in Arabic
- Preliminary injunctions or "precautionary measure orders" rarely granted
- Civil trials are conducted on the basis of exchanging written memoranda and documentary evidence, including witness statements
- Validity and infringement cases are heard in different proceedings by different courts
- Courts' judgement are not published (except for the Court of Cassation)
- No confidentiality requirements during proceedings
- No disclosure requirements
- Cost awards are generally not available



# Trademarks

# What you need to know

- ✓ GCC Trademark Law + national laws
- ✓ First-to-file jurisdictions
- ✓ Relatively broad scope of nontraditional marks protected
- √ Still single-class applications (!!!)
- ✓ Quite expensive but relatively quick proceedings
- ✓ Use requirement of 5 years either from the registration date or filing date
- ✓ Oppositions are common

- √ C&D letters are common
- ✓ Consider registering trademarks in Arabic too
- ✓ Registration of licenses is not always required, but recommended for enforcement



# **Parallel import - key considerations**

- Criminal prosecution for counterfeiting
  - GCC Customs Union
  - The Arab Convention Against Transnational Organized Crime
  - National laws
- Parallel import generally not prohibited
  - customs procedures
  - exclusive trade agency



# Trade Secrets and Know How

## **Legal Framework**

- Art. 39 of TRIPS
- National legislation
  - KSA: Regulation for the Protection of Confidential Commercial Information of 2005
  - **Bahrain:** Law No. (7) of 2003 on Trade Secrets
  - Qatar: Law No. 5 of 2005 on Trade Secrets
  - UAE: Federal Law No. 11/2021 (On the Regulation and Protection of Industrial Property Rights), section re protection of Undisclosed Information
  - Oman: Royal Decree No. 67/2008 (On the Issuance of the Law on Industrial Property Rights),
     Royal Decree No. 38/2000 (the Law of Trade Marks, Descriptions and Secrets and Protection from Unfair Competition) provisions re protection against unfair competition
- Other sources: penal codes, civil codes and commercial laws, company laws, competition protection laws, labor laws, good faith or honest behavior principles
