


# **Electronic Travel Authorisation (ETA)**

#### **ETA - Overview**

- Multiple entry digital pre-approval to travel
- Required for:
  - Tourism or visiting family and friends
  - Business or study
  - Transiting through the UK
  - Creative concession entrant (under 3 months entry)
- Valid for 2 years or until passport expiration
- Costs £10
- Typically, 3 working days
- Does not guarantee entry



#### **ETA – Application process**



Application made at least 3 days before travel via ETA App or gov.uk website [if no smartphone]

#### Light touch application

Will include personal information and any criminality declarations

'ID Check' via App to complete the identity stage of the application with Face Biometrics. Self-enrolled.

#### Crime/Security/ Identity Checks

#### Make payment:

Separate application & payment of £10 for each person who requires an ETA

#### Automated granted when:

- •applicants with no system hits
- •No negative immigration history
- Facial ID match confirmed

# Manual intervention for assessment & decision

Where identity cannot be verified, a declaration made, or an adverse trace has been found.

Decision usually within 3 working days. Usually quicker.

#### Email granting ETA with:

- Permission to travel for two years; or
- expiry of passport whichever is sooner

#### Refused:

receive a reason & directed to apply for visa if they still wish to travel

#### Travel to the UK



#### **ETA** – Decision

#### No right to administrative review or appeal

#### Will be refused where:

- applicant has received a custodial sentence of 12 months or more
- applicant has been convicted of a criminal offence in the last 12 months
- applicant's presence in the UK is not conducive to the public good because of their conduct, character, associations or other reasons
- applicant has previously breached the UK immigration laws
- false representations were made, or relevant facts were not disclosed

#### Standard Visitor required for refusals

- longer lead time due to entry clearances and complexity
- £115 for 6 months

#### ETA - Roll out


**15 November** – ETA is mandatory for Qatari nationals

**1 February 2024** – Nationals of Saudi Arabia, Oman, Bahrain, Kuwait, UAE and Jordan may apply for an ETA

**22 February 2024** – ETA is mandatory for nationals of Saudi Arabia, Oman, Bahrain, Kuwait, UAE and Jordan

Roll out to all eligible nationalities (including EU nationals) is expected by the **end of 2024** 

# Who requires an ETA?



## Who requires an ETA?

#### No ETA required

- British or Irish passport holders
- Those with permission to enter or stay in the UK, including those that are settled
- Those legally resident in Ireland who do not require a visa for travel to the UK
- Visa nationals (e.g. Turkish, Russian and South African nationals)

#### **ETA** required

- Non-visa nationals (e.g. US, Canadian, Australian, EEA and Swiss nationals)
- Children and infants (no minimum age)
- Non-visa national list recently updated

#### Visa nationals

Must obtain a standard visit visa prior to travel

Online application generates appointment to submit biometric data

Evidence of purpose of visit and intention to remain overseas required

Long term (2/5/10 year) visas are available, however each visit to the UK must be less than 6 months

#### Processing times:

- Standard (included in application fee): 15 working days
- Priority (additional £500 per applicant): 5 working days
- Super priority (additional £1,000 per applicant): 1 working day

## **Visiting the UK**

- Must not intend to work, which includes:
  - taking employment in the UK;
  - doing work for an organization or business in the UK;
  - establishing or running a business as a self-employed person;
  - doing a work placement or internship;
  - direct selling to the public;
  - providing goods and services; and
  - filling a role or providing short-term cover for a role within a UK based organization

#### **Permitted Visitor Activities**



#### **Permitted activities include:**

attending business meetings, seminars, interviews, giving talks and speeches, negotiating deals and contracts, carry out site visits and gathering information for their employment overseas



# **Employees of overseas based companies can:**

advise and consult, trouble shoot, provide training and share skills and knowledge with UK employees of the same corporate group

# **Visiting the UK**

- Must remain paid and employed outside of the UK
- Reasonable expenses:
  - Flights
  - Accommodation
  - Food
  - Directors' fees for attending board-level meetings
- Limited exceptions for permitted paid engagements

# **Looking ahead**

- From January 2024:
  - 1. broaden and clarify activities that can be undertaken in an intra-corporate setting
  - 2. offer wider coverage for the legal services sector
  - 3. simplify arrangements for those undertaking paid engagements
- Further changes to business visitor rules expected later in 2024

# **Electronic Travel Information and Authorisation System (ETIAS)**


#### **ETIAS - Overview**

- Multiple entry digital pre-approval to travel
- Valid for 3 years or until passport expiration
- Does not guarantee entry
- Cost EUR 7
- Typically, 4 working days
- Expected in mid-2025



#### **ETIAS - Countries**





# **ETIAS – Application process**

- Application made online or using the ETIAS mobile app
- ♣ Passport must be valid for at least 3 months after departure
- Recommended to apply 30 days in advance
- Additional documents can be requested
- In certain cases, an interview may be required

#### **ETIAS – Decision**

Have right to appeal on refusal, revocation or annulment

Directed to appeal to a specific European country

Appeal process and time limit to appeal varies in each country

#### Will be refused if applicant:

- used a travel document that was reported lost, stolen, misappropriated or invalidated
- poses a security, illegal immigration or high epidemic risk
- fails to reply to request for additional information, documentation or attend an interview
- has previously been refused entry and stay, accompanied with an alert in the countries information system

Can apply again in the event application is refused

## Who requires an ETIAS?

#### No ETIAS required

- Nationals of European countries
- UK nationals and their family members benefitting from the Withdrawal Agreement
- Holders of a residence permit issued by any European country
- Holders of a national long-stay visa
- Visa nationals (e.g. Turkish, Russian and South African nationals)

#### **ETIAS** required

Children and infants (no minimum age)



#### Visa nationals

- Must obtain a Schengen short stay visa
- Application submitted to:
  - the Consulate of the country to which the applicant intends to travel; or
  - the Consulate of the country in which the applicant intends to spend the most time
- Evidence of medical insurance coverage, sufficient financial resources and purpose of travel required
- Processing times dependant on the Consulate processing application

## Visiting the Schengen area

- Permitted activities will depend on the category of Schengen visa:
  - Tourist Schengen → tourism purposes only
  - Student Schengen → study within the Schengen area. Issued by educational institutions and are subject to restrictions
  - Transit Schengen → permits holders to transit via the Schengen area
  - Working Schengen → permits holders to work in a selected country and additional registration requirements might apply

## Visiting the Schengen area

- Business Schengen → work is prohibited. No set list of activities deemed to be "business activities" and subject to the conditions in each country. Examples include:
  - Attending internal and external business activities
  - Attending conferences and seminars
  - Negotiating business deals
  - Undertaking sales or marketing activities
  - Performing internal or external client audits
  - Exploring business activities
  - Attending and receiving training
- Activities should be assessed on a case-by-case basis depending on the activity and country

# **Entry/Exit System (EES)**



Electronic register of the time and place of entry and exit



Better monitoring for overstaying



Due to be implemented in Autumn 2024

## **Digitalisation of Schengen Visas**

- The current in-person visa application processes for all Schengen countries will largely be replaced and applications will instead be processed digitally via a single visa application platform
- Applicants will digitally submit information and documents and pay government fees on this platform
- In-person appointments will still be necessary for some applicants
- Visa sticker to be replaced with cryptographically signed barcode
- Implementation date to be confirmed (2028)
